From 2005 until appointed to the San Diego Superior Court in 2015, Judge Scherling's practice focused on litigation of patent, trademark and trade secret matters involving domestic and international companies, large and small, in cases throughout the country. It entailed the full range of representation and client counseling, including: preparation of complaints and counterclaims; preliminary injunctions; all aspects of fact and expert discovery; mediation and settlement; dispositive motions; trials; post-trial motions; and appeals. Shortly before his appointment to the Court, Judge Scherling was selected as a mediator by the World Intellectual Property Organization. He now mediates cases with JAMS.

Judge Scherling's legal practice in the 10 years before he was appointed to the San Diego Superior Court was devoted almost exclusively to intellectual property litigation in the federal courts. Although he worked closely with colleagues engaged in practice before the USPTO, Judge Scherling did not engage in patent or trademark prosecution. While his primary focus was patent litigation, he also litigated a number of trade secret and trademark cases. (With respect to Item 8.j. above, Judge Scherling did not work directly with survey evidence but is familiar with its uses in trademark and false advertising litigation.) Judge Scherling also worked on copyright issues in law school, on trade dress litigation as a federal law clerk and on patent/antitrust litigation while in private practice following his judicial clerkship.
