

# PRESIDENT'S Message

What an incredible year! It has been my privilege to serve as your president over the past twelve months. This organization is amazing, and I am so proud of the work the association has done in the past year to effect change in the intellectual property arena. At AIPLA, we are determined to be a change leader and over the past year we've demonstrated leadership by driving important progress.

This year we welcomed Director Andrei lancu, the Under Secretary of Commerce for Intellectual Property and the Director of the United States Patent and Trademark Office to the Washington DC area. For example, our Board of Directors reflects the diversity of our IP focus, our geographic focus and the different industries that are represented by this organization. #### **Diversity Committee**

#### **Podcasts**

#### Website

#### **Meetings & Events**

All of our stated meetings, the 2017 in Washington, DC, the 2018 Mid-Winter Institute in Palm Springs and the 2018 Spring Meeting in Seattle, continued our tradition of presenting programs that provide attendees with the opportunity for deep analysis on topics of interest to the IP community in a relaxed setting that also encourages networking. The conferences covered the most innovative technologies of the future in computer and internet security, autonomous vehicles and wearable tech, medical technology, biopharma, and entertainment. The events also featured outstanding and expanded networking opportunities - from lengthened coffee breaks, to more receptions, and our "Table Talks" luncheon, we took the "work" out of networking. In total, more than 3,000 of our members and guests took advantage of AIPLA's conferences throughout the year.

AIPLA also hosted several educational programs at our headquarters in Arlington, VA, in our Past President's Conference Center. Strategically designed to be cutting-edge and comfortable, the conference center is a modern events space and meeting center for intellectual property leaders from around the globe. AIPLA used the Conference Center to continue its 30-year tradition of working with the USPTO to provide core IP training to legal secretaries, administrators, and paralegals, launched a new Design Rights Boot Camp, continued to host the Annual Trademark Boot Camp and our Patent Cooperation Treaty Seminar. The Conference Center also saw numerous delegation visit from domestic and international IP offices.

#### Webinars

AIPLA's online programs and webinars are designed to provide membership with knowledge and skills related to areas impacting the intellectual property community, both in practice and professional development. This past year, AIPLA hosted 24 webinars, including 19 that were provided for CLE credit. Additionally, we hosted 2 Career and Practice Management programs, free programs which are designed to provide insights and best practice tips from industry experts, consultants, and advisors regarding the current issues impacting career development and law practice management



#### **Creativity in Bloom**

IP is protected by a set of legal rights with both constitutional and common law origins. A goal of these rights is to both incentivize and protect creative and inventive works...to encourage and reward the original work in planting and nurturing the seeds and hopefully to allow ideas the time and opportunity to reach their full maturity and potential and bear fruit for their creators and the community as a whole.

We believe that IP has been a major engine in the economic and artistic flowering of our country since its inclusion by our Founding Fathers in the Constitution. It is a resilient system which has been and should be able to continue to adapt to changing technologies and economic pace and environment. We believe that historically and globally, the most robust innovation and energetic research, as well as most active artistic communities, have been fostered in countries and periods with the most reliable protection of intellectual property.

We are concerned that negative perceptions and misperceptions about the intellectual property system are becoming more widespread in the public at large and that these misperceptions are in large part based on a lack of understanding of the system itself and of its historic origins and current real-world value. Our goal is to educate the public and its representatives on intellectual property and its value.

#### World IP Day!

World IP Day, launched in the year 2000 by the World Intellectual Property Organization (WIPO), was created to promote and protect creative ideas, including music, art, trademarks, writings and inventions.

Eighteen years later, World IP Day is celebrated all over the globe on April 26, and AIPLA is working to expand those celebrations across the United States. Together with a multitude of local IP law associations, Chambers of Commerce, cities, and law schools, we have been able to promote the importance of creativity and the protection of ideas nationwide.

AIPLA's Public Education Committee organized more than 14 programs in 14 different cities around the US, including an event at the USPTO and a celebration on Capitol Hill. This year's theme – "Powering change: Women in Innovation and Creativity," called for greater participation of women in the field of innovation and creativity to reap maximum benefits for society.

At the Capitol Hill event, opening remarks were made by Lisa Jorgenson, AIPLA Executive Director, followed by remarks from Andrei Iancu, Under Secretary of Commerce for Intellectual Property and Director of the US Patent and Trademark Office. A panel of women innovators spoke on their careers, motivations and ideas, and gave their opinions on how to best spur young women into leadership and senior roles in science, technology, business and the arts. This was followed by remarks from several members of Congress, including Rep. Bob Goodlatte (R-VA), Rep. Darrell Issa (R-CA), and Rep. Hank Johnson, (D-GA), and comments by our partners at the USPTO, WIPO, INTA, ABA, and the US Chamber of Commerce.

#### **Camp Invention & the National Inventor's Hall of Fame**

AIPLA continued its support and relationship with the National Inventor's Hall of Fame through our participation on the annual selection committee. We also continued to serve as a sponsor of the Hall of Fame's annual Camp Invention program, which is a program designed to energize elementary age students about learning about STEM education. These week-long programs give students a chance to attend a summer camp designed for exploration, discovery, and learning. Our support provides scholarship for students who may not otherwise afford to attend the program.







AIPLA advocacy activities serve the membership by representing members' interests in front of the US Judiciary, elected officials on Capitol Hill, and US government agencies, in addition to international agencies and organizations. While executive AIPLA staff members lead and execute on behalf of members, committees play a large role in the development of AIPLA's policy initiatives.

#### **Judicial Advocacy**

It was again a significant year for judicial advocacy at AIPLA. From October 2017 to September 2018, AIPLA advocated for the interests of its members in 4 amicus briefs filed in the Supreme Court and in the Court of Appeals for the Federal Circuit. AIPLA's amicus briefs involved a variety of intellectual property issues, including the following:

#### **Supreme Court**

- A damages award for infringement under 35 U.S.C. § 271(f) should include foreign lost profits when the harm was proximately caused by domestic infringement (WesternGeco LLC v. ION Geophysical Corp.)
- Argued that the Federal Circuit failed to give effect to a revision of the "on sale" doctrine made by the America Invents Act (AIA) which imposed a "public availability" requirement not only on the fact of an early sale but also on the subject matter of the sale. (Helsinn Healthcare S.A. v. Teva Pharmaceuticals USA, Inc.)

#### **Federal Circuit**

• Argued against awarding attorney's fees to US (Nantkwest, Inc. v. Matal).

#### 4th Circuit

 Argued that the Patent and Trademark Office has incorrectly interpreted the Lanham Act as requiring an award of attorneys' fees, win or lose, to the agency in district court proceedings reviewing decisions of the Trademark Trial and Appeal Board. (Booking.com B.V. v. The United States Patent and Trademark Office)

#### **Capitol Hill**

AIPLA continued to be active and provide its expertise on intellectual property issues on Capitol Hill, engaging with Committees, Members, and their staffs on a variety of topics such as patent subject-matter eligibility, copyright small claims, and USPTO fee-setting authority. Legislative issues and hearings relating to a number of important intellectual property issues were also closely monitored.

#### **Government Agencies**

AIPLA has remained active at the US Patent and Trademark Office, providing comments and testimony on numerous issues, including the Trademark Trial Appeal Board standard protective order; the claim construction standard for interpreting claims in trial proceedings before the Patent Trial and Appeal Board; changes to the Trademark Rules of Practice to mandate electronic filing; Office guidance to patent examiners on determining whether a claim element is well-understood, routine, conventional for purposes of subject matter eligibility; the proposed patent fee schedule, for which AIPLA also presented oral testimony at an oral hearing of the Patent Public Advisory Committee; and the Office's draft Strategic Plan for fiscal year 2018-2022.

We also provided commentary to other government offices, such as to the Copyright Office on proposed rulemaking on Copyright Office fees; to the Department of State and Office of the United States Trade Representatives (along with the USPTO) on the draft convention on the recognition and enforcement of foreign judgments relation to civil or commercial matters currently being negotiated at The Hague Conference on Private International Law; and to the Federal Trade Commission on competition and consumer protection in the 21st century hearings, for which AIPLA also presented oral testimony at the hearings.



# International Outreach

The international component of AIPLA's advocacy continued this year. Harmonization is a long-term goal, but efforts continue, with AIPLA participating in numerous meetings across the globe with the Industry Trilateral, IP5, TM5, and many other IP organizations. Many of our efforts are related to the substantive patent harmonization discussions, study questions related to international patent harmonization, classification of emerging technologies, the future developments in the Global Dossier, the harmonization of patent practices and procedures and enhanced work sharing.

AIPLA pushed harmonization forward at key meetings in Tokyo, Japan, when an AIPLA delegation attended meetings of the Industry Trilateral and the Trilateral Heads of Offices, in Louisiana, when an AIPLA delegation attended meetings of the Industry Trilateral, Industry IP5, and with IP5 Patent Office Heads and in Geneva, Switzerland September 23 when an AIPLA delegation attended meetings of the Industry Trilateral and with the Group B+ Subgroup. We also continue to engage on other fronts, such as having a representative attend the 28th Session of the Committee of Experts for the Nice Agreement, the World Intellectual Property Organization (WIPO) Sixth Session of the Working Group on the Legal Development of the Hague System for the International Registration of Industrial Designs, WIPO Working Group on the Legal Development of the Madrid System, and meetings of the Standing Advisory Committee before the European Patent Office (SACEPO) Working Party on E-Patent Process and the SACEPO Working Party on Quality, and user sessions of the TM5 mid-term

AIPLA provided comments on international intellectual property issues to a number of governmental bodies around the globe, including to Telecom Regulatory Authority of India on promoting local telecom equipment manufacturing; Health Canada on regulations amending the patent medicines regulations; China's State Administration for Industry & Commerce on the revision of trademark law; Supreme People's Court on certain issues in hearing administrative cases of patent granting and confirmation; China Food and Drug Administration on a draft

revised special approval procedure for innovative medical devices; and to the Japan Patent Office on protection of designs. AIPLA also made Statements

at the World Intellectual Property Organization's 50th General Assembly, and the 36th Session of the Intergovernmental Committee on Intellectual Property and Genetic Resources, Traditional Knowledge and Folklore.

> The Global Sector committees of AIPLA continued to focus on practice in specific regions or countries and sponsor delegation visits to Jerusalem, Tokyo, Osaka, Saint Germin en Laye, Paris, London, Milan, Munich, London, Santiago and Buenos Aires. Delegates used these trips to meet with local practitioners and engage with government officials to mutually gain a better understanding of U.S. and international practices.

# Publications and Papers

#### **AIPLA Report of the Economic Survey**

The Report provides an in-depth report on the annual incomes and related professional characteristics of intellectual property attorneys and associated patent agents. Conducted every other year, the survey also examines the economic aspects of intellectual property law practice, including individual billing rates and typical charges for representative IP law services. The 2017 edition of the Report, released in August 2017, for the first time added new information regarding non-US-originated and US-filed, but non-US prosecuted patent applications, and estimated the percentage of annual corporate IP budgets based upon types of work. Research for the 2019 edition will begin in the new year.

#### **AIPLA Quarterly Journal**

The AIPLA Quarterly Journal is a scholarly publication of the American Intellectual Property Law Association, produced through a collaboration with the George Washington University Law School. The Quarterly Journal, now in its 46th year of publication, is dedicated to presenting materials relating to intellectual property matters and is published four times per year.

#### **AIPLA Direct**

AIPLA Direct provides analysis and insight into some of the most important IP legislative, regulatory, and judicial issues facing the IP bar. AIPLA Direct is designed to be responsive to the latest developments and comes out when news is relevant. The archived AIPLA Direct stories are posted on AIPLA's website.

#### **AIPLA Newsstand**

A partnership with Lexology, a division of Globe Business Media Group, helps AIPLA share daily developments in IP as well as access to a number of articles on relevant IP topics. The AIPLA Newsstand arrives every day, but if daily is too frequent, members can change their subscription and opt for a weekly or monthly digest, and members can filter stories based on their interest in a particular area of IP or region of the world.

#### **AIPLA eBulletin**

The eBulletin is a fully digital publication that follows each of AIPLA's three stated meetings and provides an update from the President, captures activities from the meeting, and provides our committees a platform to share their projects and accomplishments with the AIPLA membership.


#### **Model Patent Jury Instructions**


