Navigating the Intersection Between IP and Regulatory Exclusivities for Protecting and Evaluating Pharmaceutical, Biologic, and Medical Device Products

This panel will discuss why IP practitioners should become familiar with regulatory exclusivities and how this knowledge brings value to stakeholders focused on product and business development in the pharmaceutical, biologic, and medical device spaces. Regulatory and patent exclusivity drive significant value during the product development life-cycle and can be critical factors in patent prosecution strategy and in the evaluation of merger and acquisition, licensing opportunities and/or litigation. In the commercialization of medical products, regulatory strategy is often inextricably intertwined with other business and legal topics, such as intellectual property protection and competitive intelligence. 

Navigating Ethical Frontiers

AI, Legal Ethics, and Risk Management--In an era where technology is revolutionizing the practice of law, it is crucial for practitioners to understand the ethical implications and risk management strategies associated with AI implementation. 3. Spouses or Accompanying Guests Must Register.

Guests over 18 pay a guest fee of \$150. 






The 2025 Maurice Klitzman Award
