# Matthias Reischle

Deputy Director, PCT Legal Division, WIPO



Matthias Reischle, a national of Germany, is Deputy Director of the PCT Legal Division of the World Intellectual Property Organization (WIPO). Matthias holds a degree from the University of Constance, Germany (1993), and a LL.M in European Legal Studies from the College of Europe, Belgium (1994). After qualifying to practice law in Germany in 1996, he worked as a legal adviser for the International Labour

Organization in Geneva. Since joining the staff of the PCT Legal Division in 1998, he has participated in the drafting and implementation of various amendments to the Regulations under the PCT and other PCT-related texts such as the Administrative Instructions, various Guidelines, and publications such as the PCT Applicant's Guide and the PCT Newsletter. He regularly participates in training courses, seminars and international-level meetings on the PCT and advises applicants and their representatives concerning PCT procedure.



Michael Neas is the Deputy Director of the International Patent Legal Administration (formerly PCT Legal) at the United States Patent & Trademark Office. Mr. Neas' staff provides training on the filing and prosecution of PCT and U.S. national stage applications to inventors, applicants, patent practitioners and paralegals.
