Re: Nomination of Katherine Vidal to be the Under Secretary of Commerce for Intellectual Property and Director of the United States Patent and Trademark Office

Dear Chair Durbin and Ranking Member Grassley:

The American Intellectual Property Law Association ("AIPLA") is pleased to submit this letter in response to the nomination of Katherine Vidal to be the Under Secretary of Commerce for Intellectual Property and Director of the United States Patent and Trademark Office ("USPTO").

Founded in 1897, AIPLA is a national bar association of approximately 8,500 members who are engaged in private or corporate practice, in government service, and in the academic community. AIPLA members represent a wide and diverse spectrum of individuals, companies, and institutions involved directly or indirectly in the practice of patent (utility and design), trademark, copyright, trade secret, and unfair competition law, as well as other fields of law affecting intellectual property. Our members represent both owners and users of intellectual property. Our mission includes helping to establish and maintain fair and effective laws and policies that stimulate and reward invention but that also balance the public's interest in healthy competition, reasonable costs, and basic fairness. As such, our membership has a longstanding interest in an effectively functioning USPTO.

Because of the AIPLA's profound interest in the effectiveness of the Presidentially appointed leader of the USPTO, it has established a set of criteria that address the needed qualifications for an individual appointed to serve in this capacity. Based on the AIPLA's decades of work with the USPTO's leadership, we believe that a successful Director must possess a deep background and understanding of intellectual property law, as well as demonstrated

executive leadership ability through successfully managing a substantially sized organization.
